SUBJECT

AMENDMENT TO SEC. 3,2 OF CMO 19-2019 ON "DECENTRALIZING THE CPRS ACTIVATION OF ENTITIES ACCREDITED BY OTHER **AGENCIES** THE RENEWAL GOVERNMENT AND ACCREDITATION OF CUSTOMS BROKERS TO THE DISTRICT COLLECTORS"

Pursuant to Section 817 of Republic Act No. 10863 otherwise known as the Customs Modernization and Tariff Act (CMTA), Section 3.2 of CMO 19-2019 is hereby amended to read as follows:

3.2 For Registration of Importers/Exporters Accredited by Other Government Agencies, Entities or Offices. Other government agencies as used in this order shall refer to any of the various units of the government of the Philippines, including a department, bureau, office, instrumentality or government-owned and controlled corporation, or any of the Free Zone Authorities (PEZA, SBMA, AFAB, CDC, etc.)
