Rules and Regulations Amending/Supplementing

CMO NO. 20-89

In order to enhance the attainment of the objectives set forth in CMO No. 20-89 and provide for the automatic amendment, revision and/or updating of published values of imported articles, thereby, render such published values as current as possible, said CMO is hereby amended/supplemented as follows:

- 1. On the sixth month after publication in the Revision Order or after issuance of the SGS-CRF where the value's therein had not been published, all such published values and SGS-CRF values shall immediately be reported within five (5) working days by the Principal Appraiser concerned to the District Collector, with a recommendation either for amendment, revision, updating or republication and specifically indicating therein the basis/justication for the recommendation.
- 2. Within five (5) working days from the submission of the reports, the District Collector shall forward, with his appropriate recommendation, the same to the Chief, Valuation and Classification Division (VCD), who shall act thereon within five (5) working days from receipt thereof.

3. All such values so recommended by the District Collector and those contained in the daily reports as required under CMO No. 20-89 shall be included by the VCD in the immediately succeeding Revision Order.

- 4. For purposes of compliance with this Order, Principal Appraisers shall render their reports per format shown in Annex "A" hereof.
- 5. Transitory Provision published and SGS-CRF values as herein defined already beyond six (6) months at the time this Order is issued, shall immediately be reported by all Principal Appraisers concerned, using the same format shown in Annex "A".
- 6. All provisions of CMO No. 20-89 inconsistent herewith are hereby deemed repealed or modified accordingly.

This Order shall take effect immediately upon approval.
