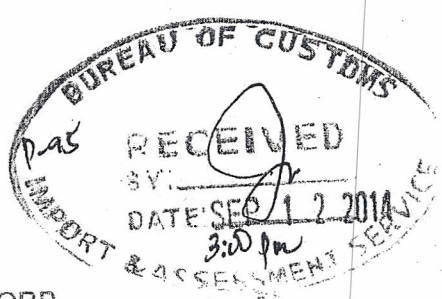

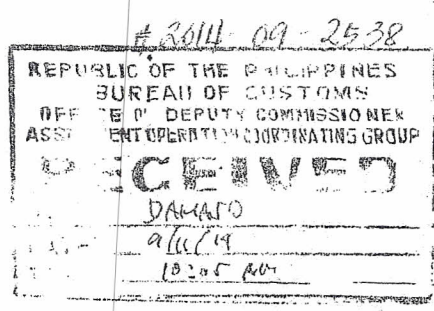
In view hereof, the project's certificates of registration shall be deleted from the Board's Book of Registry and shall cease to be entitled to any incentives under E.O. 226.
