

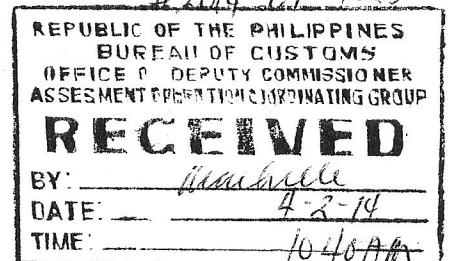
In view hereof, the project's certificate of registration shall be deleted from the Board's Book of Registry and shall cease to be entitled to any incentives under E.O. 226.

Please be guided accordingly.

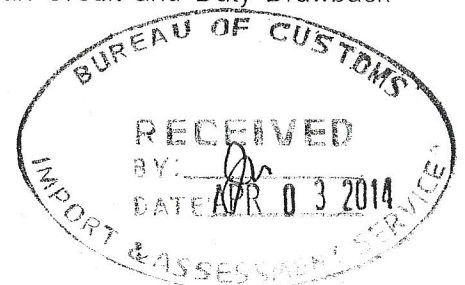
