CUSTOMS MEMORANDUM CIRCULAR No. <u>186 - 2017</u>

To: All Collectors of Customs Importers, Customs Brokers, Brokers' Representatives and All Others Concerned

In line with Customs Memorandum Order No. 15 - 2016, the Exchange Rate below duly issued by the Bangko Sentral ng Pilipinas on 30 November 8, 2017 shall be the applicable Rate of Exchange for the week November 9, 2017 – November 15, 2017 for both the regular consumption entries (formal and informal), warehouse entries as well as withdrawal entries for shipments entered under warehousing.
