- All import entries under Tariff Headings and Commodities, with declared values falling below the reference values herein provided shall be released only when the Officials of the Formal Entry division have reviewed and ascertained the accuracy of the declared value pursuant to Section 707 of Republic Act 10863 also known as Customs Modernization and Tariff Act (CMTA).

COMMODITIES	H.S. CODE	REFERENCE VALUES
Dextrose Anhydrous	1702.30	US\$ 650/ton
Dextrose Monohydrate	1702.30	US\$ 550/ton
Fructose Syrup	1702.60	US\$ 540 (Tin Can)
Glucose Syrup	1702.30	US\$ 530 (Tin Can)
Malto Dextrin	1702.90	US\$ 750

The importers right to appeal to the decision of the Bureau shall be governed by the rules of Section 1106 of the same Act.

- Non-compliance by any Customs Officials with any provision of this Memorandum will be considered simple neglect of duty pursuant to CMO 25-2010, Title IV, Section 2, and shall be punishable upon second offense by dismissal from the service.
