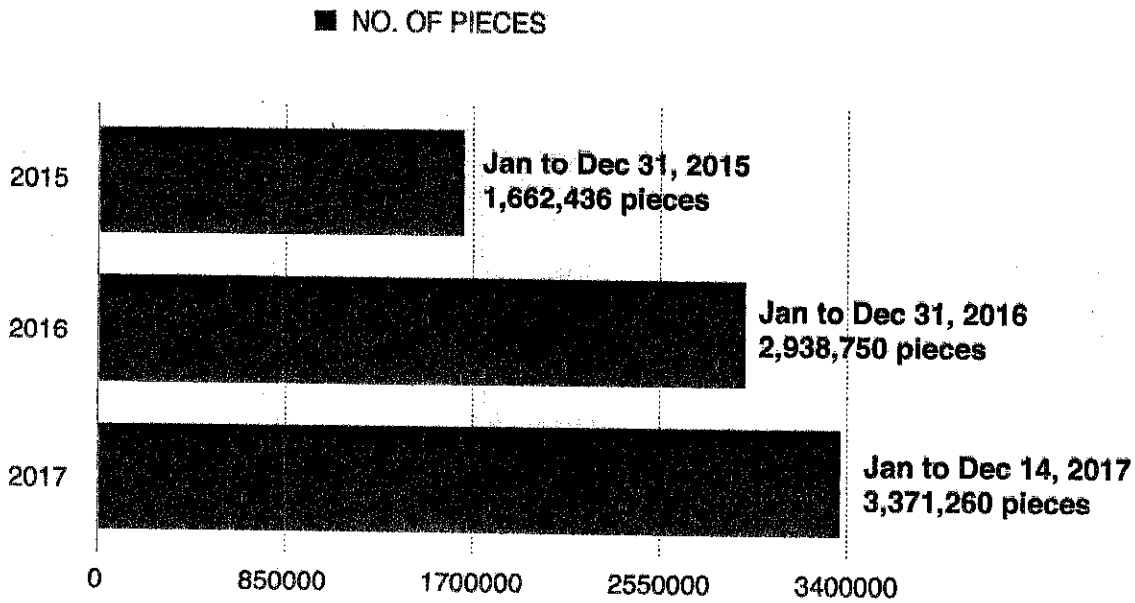
REGULATION, ENFORCEMENT & JUDICIAL

OMB continues to strengthen its regulatory policies and intensify enforcement activities. It is also important to note that the promulgation of 2016 Memorandum Circulars¹ translated into an influx of registrants. All of these factors combined into a perfect storm that **resulted** in a **significant increase** in revenue collection and estimated value of seized optical and magnetic media.

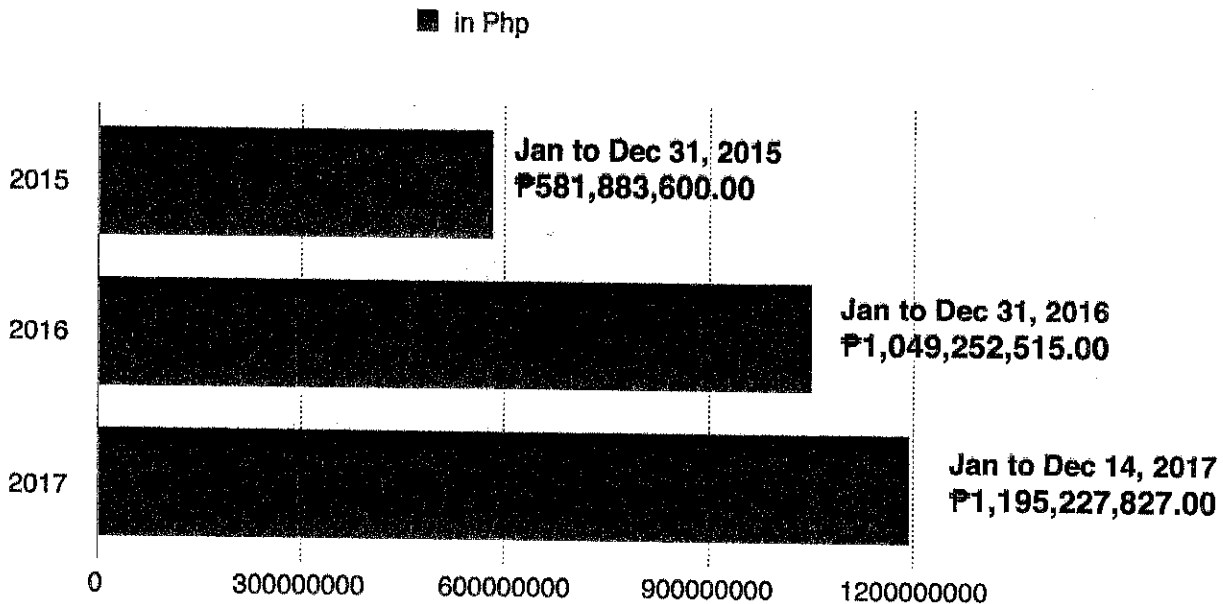
