Thank you for your letter dated 15 January 2018, and received by this office only last 14 February, requesting for clarification on the President's directive to the Bureau of Customs to refrain from opening the luggage of passengers arriving in the Philippines.

We wish to note that per Presidential Directive no. 2017-0100 addressed to the Secretary of Transportation and the Commissioners of Immigration and Customs issued last 14 February 2018, it was clarified that the directive - which was reiterated by the President during his 09 February meeting with DOLE and DFA - covers only returning Overseas Filipinos Workers (OFWs). It was further clarified that the directive is without prejudice to the stringent and proper implementation of security and safety measures.

SUBJECT : **REFRAIN FROM OPENING THE LUGGAGE OF OFWS**

DATE : 14 February 2018

During the President's meeting with DOLE and DFA and Press Conference at the Matina Enclaves, Davao City on 09 February 2018, he emphasized that the protection of our Overseas Filipino Workers (OFWs) should start here in the country. Thus, the President directed the DOTr, BI, and BOC to refrain from opening the luggage of OFWs to avoid incidents of luggage theft, without prejudice to the stringent and proper implementation of security and safety measures.

We note that this is a reiteration of the President's directive in various engagements¹. We note further that this memorandum is being issued as a formality as said directive has been communicated in advance to the DOTr Secretary and the BI and BOC Commissioners.

Kindly submit a report on your compliance with this directive, indicating the reference number above, not later than fifteen (15) days upon receipt of this memo, to the Presidential Management Staff through directives@pms.gov.ph.
