Dear Commissioner Lapeña:

Greetings.

The Department of Agriculture (DA) is mandated to implement trade remedy measures prescribed in the Anti-dumping Act of 1999 (RA 8752), Countervailing Act of 1999 (RA 8751), and Safeguard Measures Act (RA 8800). In order to effectively implement these laws, a comprehensive trade database of agricultural products is necessary for the evaluation and analysis of data.

We are currently updating the trade database for agricultural products to carry out the mandate of the abovementioned laws. However, we are experiencing difficulties retrieving historical data in the years 1983 – 1991 from different sources (e.g. Philippine Statistics Authority (PSA), UN Comtrade and Trade Map). These historical data are vital in computing the trigger prices of agricultural products eligible for Special Safeguard (SSG) Measures as a trigger price is based on the 1986 – 1988 average import CIF price of a product (based on the Agreement on Agriculture in the World Trade Organization). In order to monitor the trade data and fully implement the SSG measures, the DA and BOC need a complete list of SSG-eligible products and their corresponding trigger prices which is necessary in computing the SSG duty per shipment.

In view of this, we would like to request the BOC to provide the DA with a data set of agricultural import and export products from 1983 – 1991 with the following information: (a) HSCODE/AHTN; (b) Product Description; (c) Importing Country (for export data) and Exporting Country (for import data); (d) Volume and unit of measurement; and (e) Value (FOB, CIF) in USD and PhP. These will be used as reference for the computation of trigger prices of SSG-eligible products.
