Declaration of origin of goods imported into Brazil



Dear Commissioner Faeldon,

This Office provides the Bureau of Customs (BOC) the following information conveyed by the Embassy of Brazil regarding procedures related to declarations of origin of goods imported into Brazil, regulated by Ordinance 23:

- With regard to non-preferential origin of goods, certificates of origin issued by the governmental or non-governmental organizations from the country of origin of the goods are no longer accepted as documental proofs of origin. Instead, the producer or the exporter of the goods must fill and sign the form in Annex XXVI of Ordinance 23, as stipulated on its Article 15-A (attached).
- Declarations according to the model in Annex XXVI have replaced all documents previously accepted by the Brazilian authorities as certificates of non-preferential origin of goods. It has no longer been necessary, therefore, to send specimens of signatures and stamps of authorities and organizations from the country of origin.
- Procedures regarding certification of preferential origin of goods to be imported remain the same.
