In line with the herein attached letters dated 5 July 2017 from MCC Transport Singapore / MCC Transport Philippines / MAERSK Filipinas Inc., requesting for consideration and leniency in the imposition of fines to their shipments which have arrived and will be arriving onboard vessels without prior lodgment of manifest in the E2M system, please be guided by Sec. 3.13. of CMO 19-2015, "Revised Procedures for the Mandatory Submission of electronic sea Manifest in the E2M" which provides the exemptions, to wit:

"Late submission of the e-IFM and e-CCM shall be considered with justifiable cause and not subject to penalty under the following circumstances:

- E2M system break-down or technical problems of the system and power failure;
- VASP technical problems;
- Fortuitous events;
- Late submission of IFM, in case of CCM;
- Early arrival of the vessel from that of the original schedule.

Under the above circumstances, submission of IFM and/or CCM is allowed to be submitted within twenty four (24) hours from the cessation of the event except in the case of early arrival of the vessel, within 24 hours from the arrival."

Please be guided accordingly.
