



4 DESCRIPTION OF GOOD

"SAN REMO TOMATO, ONION & GARLIC HOMESTYLE PASTA SAUCE"

Based on the product specifications, ingredients declaration, production process flowchart, photograph of the product, and sample submitted, subject article is a red pasta sauce made of tomatoes (78%) (diced tomatoes, tomato puree, tomato paste, citric acid, and mineral salt), onion, water, olive oil, salt, vegetable oil, sugar, garlic, natural flavours, herbs, spices, and natural colour (paprika oleoresin). Subject article is packed in 500-g glass jars.



REASONS FOR CLASSIFICATION

Heading 21.03 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers, among others, sauces and preparations therefor. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers preparations, generally of a highly spiced character, used to flavour certain dishes (meat, fish, salads, etc.), and made from various ingredients (eggs, vegetables, meat, fruit, flours, starches, oil, vinegar, sugar, spices, mustard, flavourings, etc.). Sauces are generally in liquid form and preparations for sauces are usually in the form of powders to which only milk, water, etc. need to be added to obtain a sauce. Sauces are normally added to a food as it cooks or as it is served. Sauces provide flavour, moisture, and a contrast in texture and colour. They may also serve as a medium in which food is contained, for example, the velouté sauce of creamed chicken. The heading also includes certain preparations, based on vegetables or fruit, which are mainly liquids, emulsions or suspensions, and sometimes contain visible pieces of vegetables or fruit. These preparations differ from prepared or preserved vegetables and fruit of Chapter 20 in that they are used as sauces, i.e., as an accompaniment to food or in the preparation of certain food dishes, but are not intended to be eaten by themselves. Examples of products covered by the heading are tomato ketchup (a preparation made from tomato purée, sugar, vinegar, salt and spices) and other tomato sauces, among others.

In view thereof, subject article is classified under AHTN 2022 subheading 2103.20.00, with a Most Favoured Nation (MFN) rate of duty of 10% ad valorem and ASEAN-Australia-New Zealand Free Trade Area (AANZFTA) rate of duty of zero, subject to the submission of Certificate of Origin (CO) Form "AANZ".

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.



4 DESCRIPTION OF GOOD

"SAN REMO BOLOGNESE & MUSHROOM HOMESTYLE PASTA SAUCE"

Based on the product specifications, ingredients declaration, production process flowchart, photograph of the product, and sample submitted, subject article is a Bolognese and mushroom pasta sauce made of tomatoes (70%) (diced tomatoes, tomato puree, tomato paste, citric acid, and mineral salt), water, mushrooms, onion, vegetable oil, sugar, maize starch, cheese, salt, natural flavours, mushroom extract, herbs, and spices. Subject article is packed in 500-g giass jars.



5 REASONS FOR CLASSIFICATION

Heading 21.03 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers, among others, sauces and preparations therefor. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers preparations, generally of a highly spiced character, used to flavour flours, starches, oil, vinegar, sugar, spices, mustard, flavourings, etc.). Sauces are generally in liquid to be added to obtain a sauce. Sauces are normally added to a food as it cooks or as it is served. Sauces provide flavour, moisture, and a contrast in texture and colour. They may also serve as a medium in which food is contained, for example, the velouté sauce of creamed chicken. The heading suspensions, and sometimes contain visible pieces of vegetables or fruit, which are mainly liquids, emulsions or prepared or preserved vegetables and fruit of Chapter 20 in that they are used as sauces, i.e., as an accompaniment to food or in the preparation of certain food dishes, but are not intended to be eaten by tomato purée, sugar, vinegar, salt and spices) and other tomato sauces, among others.

In view thereof, subject article is classified under AHTN 2022 subheading 2103.20.00, with a Most Favoured Nation (MFN) rate of duty of 10% ad valorem and ASEAN-Australia-New Zealand Free "AANZ".

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
