



#### **DESCRIPTION OF GOOD**

### "SHARP 42" LCD ASSEMBLY, PART CODE: A3KUKEGLTP"

Based on the technical specifications and drawings submitted, subject article is a liquid crystal display (LCD) unit and cabinet assembly of a light-emitting diode (LED) television (TV) set. It consists of the following major parts:

Quantity	Part Name	Description
1	Open Cell Panel	LCD screen display
1	Optical Sheet	Refracts backlight for uniform illumination of open cell panel
1	Diffusion Plate	Diffuses LED bar (backlight)
1	Reflector Sheet	Reflects LED bar (backlight) for better illumination
3	LED Bar	Backlight for LCD panel
1	KS Cab A (Front Cabinet)	
1	KS P Frame (Panel Frame)	Hold/house the components/parts of the television set
1	Backlight Chassis	
1	Cab B (Back Cabinet)	<u></u>

Subject parts are to be imported as a sub-assembled TV module without the tuner. The assembly/module, together with the motherboard and power unit, Wi-Fi unit, speaker, wires, antenna adaptor converter, buttons, screws, and other parts will be assembled locally to make a complete LED TV

#### **REASONS FOR CLASSIFICATION**

Heading 85.29 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers parts suitable for use solely or principally with the apparatus of headings 85.24 to 85.28. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that subject to general provisions regarding the classification of parts, this heading covers parts of the apparatus of the five preceding headings. The range of parts classified here includes, among others, cases and cabinets specialised to receive the apparatus of headings 85.25 to 85.28.

In view thereof, subject article is classified under AHTN 2022 subheading 8529.90.91, with a Most Favoured Nation (MFN) rate of duty of zero and ASEAN Trade in Goods Agreement (ATIGA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "D".

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

#### **DESCRIPTION OF GOOD**

#### "ULTRASOUND PROBE, MODEL NO.: L3-12-RS"

Based on the brochure, specifications, and other technical information submitted, subject article is an ultrasonic wideband linear array probe. When connected to a compatible ultrasound machine, it allows the non-invasive internal scanning of the human body by transducing ultrasonic mechanical waves and picking up the reflected waves, and then bouncing them back to the machine. Subject article can be used in a variety of clinical applications, such as in vascular, neonatal and pediatrics. It has the following specifications:

#### REASONS FOR CLASSIFICATION

Heading 90.18 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2022 covers instruments and appliances used in medical, surgical, dental or veterinary sciences, including scintigraphic apparatus, other electro-medical apparatus and sight-testing instruments. The pertinent Harmonized System (HS) Subheading Explanatory Notes to subheading 9018.12 state that this subheading covers electrodiagnostic ultrasonic scanning apparatus. This apparatus operates by sending high-frequency sound waves into the human body through a transducer. The transducer is placed in contact with the body, and alternately emits short pulses of ultrasound and "listens" for their echoes. The echoes result from the sound waves being reflected by the organs within the body, and their characteristics are interpreted to yield information about the location, size, shape and texture of the tissues. Interpretation is generally carried out by an automatic data processing machine, with the output being presented as a video image of the tissues. This method of body scanning is used for examining the foetuses of pregnant women. It is also well suited for the examination of the breasts, heart, liver and gall-bladder.

Further, subject to the provisions of Notes 1 and 2 to this Chapter, parts and accessories of apparatus or appliances of this heading remain classified here.

In view thereof, subject article is classified under AHTN 2022 subheading 9018.12.00, with a Most Favoured Nation (MFN) rate of duty of zero and ASEAN-China Free Trade Area (ACFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "E".

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
