The owner of Vital Resources Trading Company is requesting for the restitution of a lost tax credit certificate issued May 15, 1992.


In this connection, attached is the letter dated December 12, 1992 informing this Bureau that Tax Credit Certificate No. 09057 issued in favor of said company was lost and the same cannot be located as manifested in the enclosed copy of the Affidavit of Loss executed by Mr. Aproniano G. Edano, Jr., Proprietor of aforementioned firm.

Henceforth, the lost certificate is considered null and void; shall not be valid and honored. Payment of any obligation with the same shall not be accepted.

Utilization of said certificate in whole or in part shall be relayed to this Office immediately. Hence, a replacement therefor shall only be issued after the Notice of Loss of subject tax credit certificate shall have been published for two (2) consecutive weeks in a newspaper of general circulation and the corresponding report shall have been generated from all collection districts that the same TCC has not been applied for payment.

Application of the same for any liability to this Agency or the Bureau of Internal Revenue should be reported without delay to this Office for appropriate action against party using it illegally.

All concerned shall be guided accordingly.

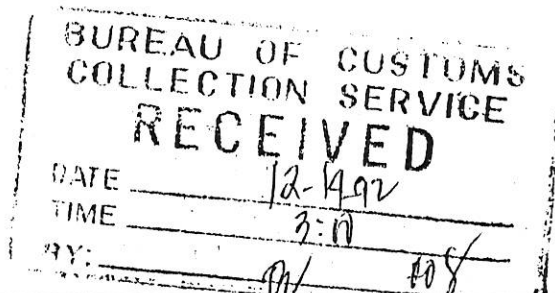


AFFIDAVIT OF LOSS
