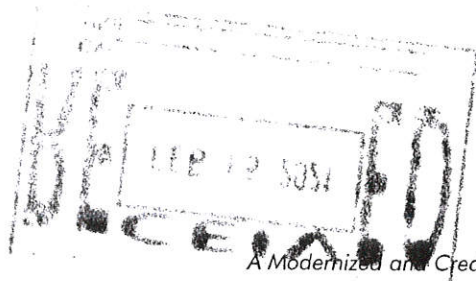

Please be informed that effective 01 January 2021 Myanmar's Department of Trade will implement the electronically signed and sealed Certificate of Origin (CO) and the CO Verification Platform for the following Free Trade Agreements (FTAs).

- a. ASEAN- Korea Free Trade Agreement (AKFTA)
- b. ASEAN-Japan Comprehensive Economic Partnership (AJCEP)
- c. ASEAN - Australia New Zealand Free Trade Area (AANZFTA)
- d. ASEAN- Hongkong Free Trade Agreement (AHKFTA)

Myanmar would like to inform that effective from 1st January 2021, Department of trade under Ministry of Commerce will be introducing the affixed electronic signed and sealed Certificates of Origin and CO verification platform for the following Free Trade Agreements (FTAs):

- (i) ASEAN-Korea Free Trade Agreement (AKFTA)
- (ii) ASEAN-Japan Comprehensive Economic Partnership (AJCEP)
- (iii) ASEAN-Australia New Zealand Free Trade Area (AANZ)
- (iv) ASEAN- Hong Kong Free Trade Agreement (AHKFTA)

CO Verification Website will provide the customs authorities of the relevant importing Parties to be able to check the authenticity of affixed electronic signed and sealed certificates. This website will be available from 1 January 2021 onwards. The importing customs authority can verify the authenticity of the electronically signed and sealed certificates on the "CO Verification Platform website: <https://verificationco.myanmartradenet.com/>. The access to the CO Verification System is password-protected, therefore, each ASEAN Member States and FTA partners are provided with individual username and password as attached.

The User Guide for the CO Verification System is attached. We would also like to highlight that the username, password and the User Guide should only be circulated to government focal points and must not be disseminated to any unauthorised or unintended or unrelated party or person.

Following that intention, kindly assist us to circulate the information to related authorized agencies in ASEAN Member States and regarding ASEAN Free Trade Agreement Partners in order to facilitate our international trade.

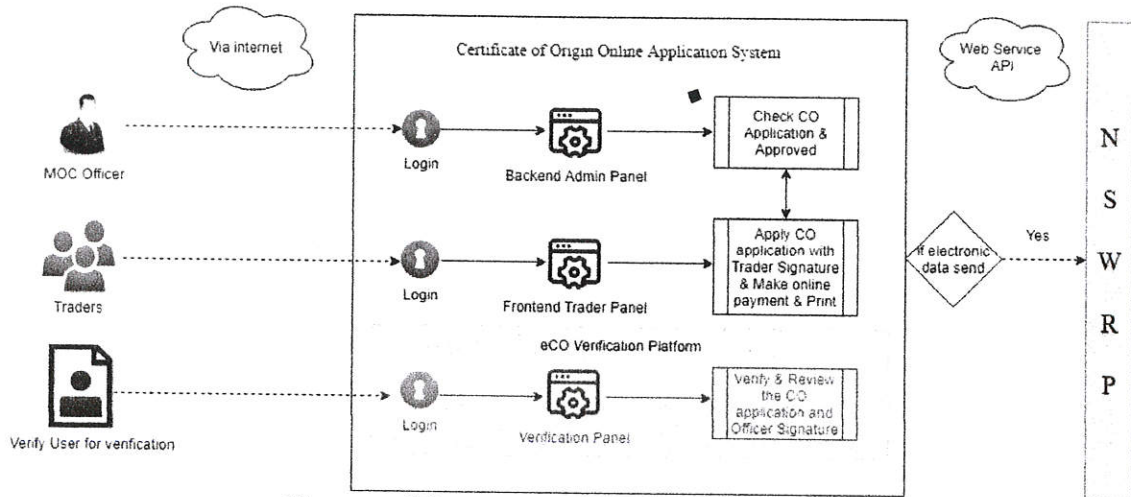


Figure: eCO system and verification platform

How to use the system

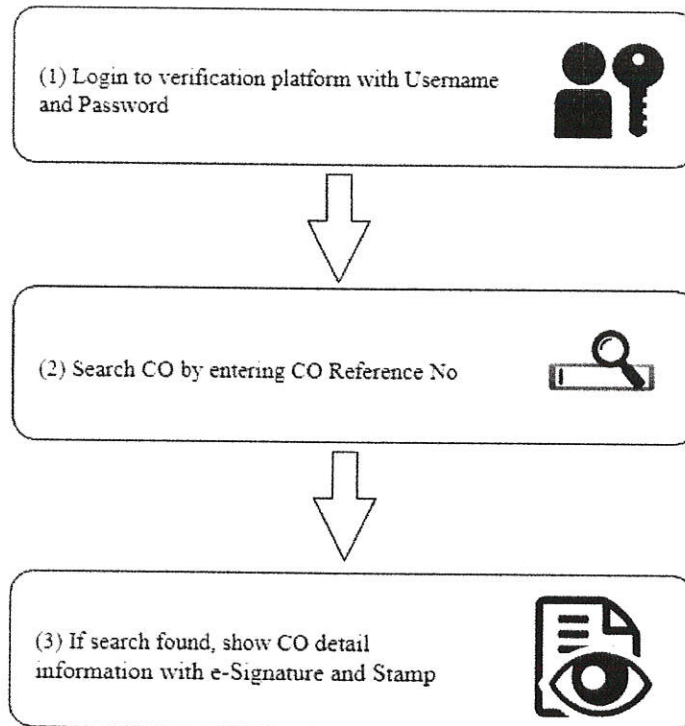


Figure: How to use the system

The user who wants to verify the eCO application needs to be logged in the verification panel. After logged in the user can be verified eCO application and MOC officer's signature.

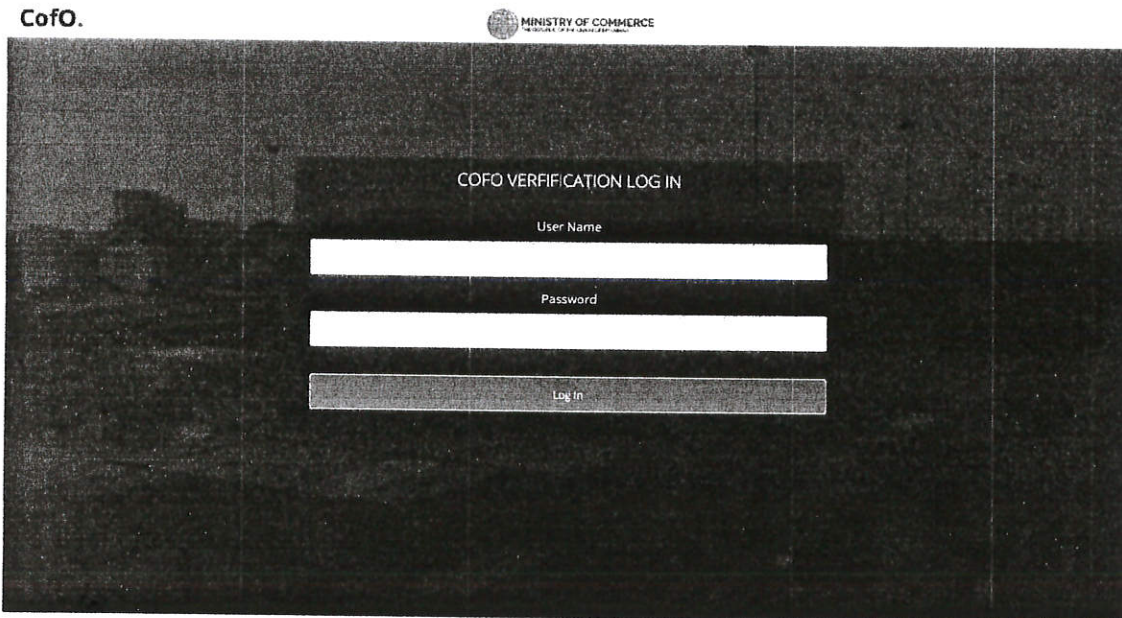


Figure: Verification Panel Login Authentication

To verify eCO application

Click on Verify Certificate of Origin and enter the eCO application reference no which you want to verify.
