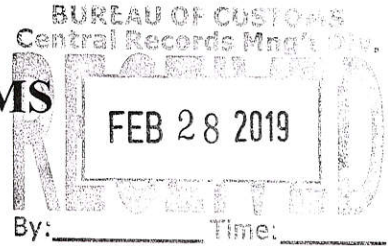

SUBJECT : JURISDICTION OVER IRASAN, PRESIDENT M. A. ROXAS, ZAMBOANGA DEL NORTE

In resolving the issue on who has jurisdiction over Irasan, Zamboanga del Norte, we cite CAO No. 07-88, to wit:

Tenth. – The District of Cagayan de Oro, comprising the provinces of Misamis Oriental, Misamis Occidental, Lanao del Norte, Lanao del Sur, Bukidnon, Camiguin Island, and all the islands within the jurisdiction of said provinces, in which Cagayan de Oro City, Misamis Oriental, shall be the principal port entry. Its sub-ports of entry are Iligan City, Lanao del Norte and Ozamis City, Misamis Occidental;

The Subport of Ozamis shall comprise the provinces of Misamis Occidental and those portions of the provinces of Zamboanga del Norte and Zamboanga del Sur, located north of a straight line beginning from the costal boundary of Zamboanga del Sur and including the town of Labason on the northern coast of Zamboanga del Norte and all the islands within the territorial jurisdiction of Ozamis City.

Irasan, which is north of Labason, is, therefore, under the jurisdiction of the Subport of Ozamis.

Attached for your ready reference is a copy of the said CAO.

CUSTOMS ADMINISTRATIVE ORDER

NO. 7-88

SUBJECT: Amending CAO 10-76 dated 23 February 1976 redefining the jurisdictional limits of Customs Collection District of Cagayan de Oro pursuant to Section 701 of the Tariff and Customs Code of the Philippines


Pursuant to the provisions of Section 701 of the Tariff and Customs Code, Paragraph 1 Subparagraph 10 of CAO No. 10-76 is hereby amended to read as follows:

"Tenth: The District of Cagayan de Oro, comprising the provinces of Misamis Oriental, Misamis Occidental, Lanao del Norte, Lanao del Sur, Bukidnon, Camiguin Island, and all islands within the jurisdiction of said provinces, in which Cagayan de Oro City, Misamis Oriental, shall be the principal port of entry. Its subports of entries are Iligan City, Lanao del Sur and Ozamis City."


The Subport of Ozamis shall comprise the provinces of Misamis Occidental and those portions of the provinces of Zamboanga del Norte and Zamboanga del Sur, located north of a straight line beginning from the coastal boundary of Zamboanga del Sur and including the town of Labason on the northern coast of Zamboanga del Norte and all the islands within the territorial jurisdiction of Ozamis City.

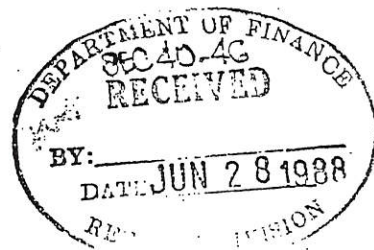

MEMORANDUM for:

The Secretary of Finance

SUBJECT: Proposed Customs Administrative Order (CAO) to amend CAO No. 10-76 dated 23 February 1976 redefining the jurisdictional limits of the District of Cagayan de Oro.

Pursuant to Section 701 of the Tariff and Customs Code of the Philippines, as amended, as implemented by CAO No. 10-76, the jurisdictional limits of the Collection District of Cagayan de Oro is proposed to be redefined.

The amendment is anchored on the following grounds:

- a. The geographical locations of the loading points are closer to the Port of Ozamis than of the Port of Zamboanga;
- b. The inadequate and inconvenient transportation facilities to the Port of Zamboanga from the existing loading points negate effective administrative supervision.

In view thereof, it is respectfully recommended that the proposed CAO be approved.
