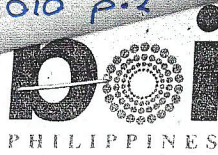

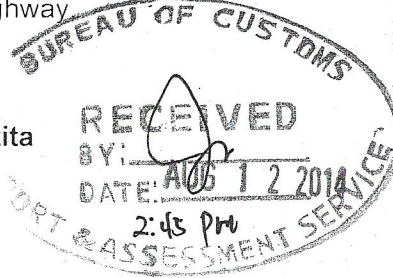

This refers to your letter dated 31 July 2013, requesting for the cancellation of your BOI Certificate of Registration No. EP2001-162 dated 12 October 2001.

On 22 July 2014, this Office **CANCELLED** the BOI registration of **CONCEPCION-CARRIER AIR CONDITIONING COMPANY** as Existing and Expanding Producer of Air Conditioners on a Non-Pioneer status under BOI Certificate of Registration No. EP2001-162 issued on 12 October 2001 due to lapse of incentives.

Furthermore, due to the loss of the original copy of the certificate of registration, the firm is required to execute an Affidavit of Loss, publish a Notice of Loss in a newspaper of general circulation, and submit proof thereof to BOI. Hence, in view of this cancellation, BOI Certificate of Registration No. EP2001-162 dated 12 October 2001 shall be deleted from the Board's Book of Registry.
