SECTION I. INVITATION TO BID

"Procurement of Third-Party Call Center Services for the Bureau of Customs"

- 1. The Bureau of Customs (BOC) through the authorized appropriations under the CY 2023 National Expenditure Program (NEP) intends to apply the sum of Four Million Five Hundred Fifty-Nine Thousand Five Hundred Twenty Pesos (Php4,559,520.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the "Procurement of Third-Party Call Center Services for the Bureau of Customs" Bids received in excess of the ABC shall be automatically rejected at the bid opening.
- 2. The Bureau of Customs now invites bids for the above Procurement Project for the period January 2023 to December 2023. Delivery of the Services which is required specified in the Schedule of Requirements. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective bidders may obtain further information from the BOC Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on October 28, 2022, from the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (P10,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented in person.
- 6. The BOC will hold a Pre-Bid Conference on November 04, 2022, 10:00 a.m. at the GSD Conference Room, Ground Floor, OCOM Building, South Harbor, Gate 3, Port Area, Manila, and/or through videoconferencing/webcasting via **Microsoft Teams**, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before November 16, 2022, 9:30 a.m. Late bids shall not be accepted.
