1.0 Pursuant to CMO 3-2013 dated July 16, 2013 implementing RA 10154, otherwise known as an Act Requiring All Concerned Government Agencies to Ensure the Early Release of Retirement Pay, Pension, Gratuities and other Benefits of Retiring Government Employees; Civil Service Commission Resolution, to ensure efficient processing of Retirement and/or separation from the Bureau, all retiring/resigning employees of the BOC are reminded of the following:

- 4.0 Be reminded that processing of Retirement/Separation shall only be processed by the BOC employee himself/herself. However, should the BOC employee can no longer process his/her retirement/separation from the Bureau, any relative (by consanguinity or affinity) may be authorized to process the employee's retirement/separation under the provisions of a Special Power of Attorney (SPA).
- 5.0 Administrative Officers of the Bureau are advised not to transact business, relevant to retirement/ separation, to anyone who is not a BOC employee without an SPA. Employees are likewise reminded not to deal with FIXERS who are volunteering to process retirement/separation in behalf of the employee.
- 6.0 Filing of retirement/separation from the Bureau must be done at least one hundred (100) days prior to retirement or at least thirty (30) days prior to the effectivity of resignation.
- 7.0 Should submitted documents fail to comply with the prescribed period, please be notified that the release of benefits shall be moved corresponding to the number of days of delay of submitted of complete requirements.
- 8.0 Attached is the updated and corrected list of employees due for compulsory/optional retirement, and resignation. Also attached are the forms mentioned above.
- 9.0 For strict compliance.
