Attached is a copy of letter dated July 18, 2018 of Assistant Secretary Leo M. Herrera-Lim, Office of the Undersecretary for International Economic Relations, with attached Note dated May 18, 2018 of the General Administration of Customs of the People's Republic of China (GACC) on the **New Sample of Inspection and Quarantine Certificates and Related Stamps** effective **August 21, 2018**.

Relative thereto, please note of the following:

1. The General Administration of Quality Supervision, Inspection and Quarantine (AQSIQ) have been integrated to GACC. Thus, GACC will start to use the new inspection and quarantine certificates and new stamps;
2. The revision of the inspection and quarantine certificates which includes the following:
 - a. All inspection and quarantine certificates issued by China Customs for exporting goods; and
 - b. All quarantine certificates including:
 - i) International Certificate of Vaccination or Prophylaxis;
 - ii) Certificate of Health Examination for International Traveler;
 - iii) Aids Testing Report; and

- iv) Certificate of Verification for Physical Examination Record for Foreigners or Overseas Chinese;
- c. Logo of the certificate has changed from “” to “”;
- d. The former content indicated in the Certificates which referred to the name of “AQSIQ” and “Entry-Exit Inspection and Quarantine Bureau” are revised to “GACC” and “Customs” accordingly; and
- e. No amendment is made on the format of the certificates.
3. The new issuing authorities of the inspection and quarantine certificates will be the 42 Customs Districts of GACC, namely:
