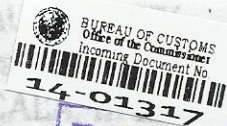

GREETINGS:

WHEREAS, this Court in its order dated, January 29, 2014, granted the Application for a Writ of Preliminary Injunction upon posting by petitioner of an injunction bond in the amount of TEN MILLION PESOS (P10,000,000.00) in favor of the respondents to answer for any and all damages that the latter may suffer because of the injunction;


WHEREAS, the petitioner posted a surety bond in the amount of TEN MILLION PESOS (P 10,000,000.00) for preliminary injunction;

NOW THEREFORE, respondents NATIONAL FOOD AUTHORITY, HON. ORLAN A. CALAYAG, in his capacity as the Administrator of the National Food Authority, NFA COUNCIL, HON. PROCESO J. ALCALA, in his capacity as Chairman of the NFA Council, BUREAU OF CUSTOMS, DISTRICT COLLECTORS in their capacity as the District Collectors for the Port of Manila, North and South Harbor, OFFICE OF THE SOLICITOR GENERAL and all persons acting on their behalf and/or under their direction and control are enjoined from implementing NFA Memorandum Circular No. AO-2K13-03-003; requiring the procurement of an import permit for all rice importation to the Philippines by the petitioner in the Port of Manila; seizing, alerting and/or holding petitioner's rice shipments, covered by the Bills of Lading, to wit: MCC388546, MCC388541, HDMUHMML0203884, HDMUHMML0203992, SITGBKMN013321A, SITGBKMN013321B, YMLUI490175790, YMLUI490175790, YMLUI490175606A, YMLUI490176260, YMLUI490175869, YMLUI490175869A, APLU074794946, APLU074808090, APLU074808093, APLU074808100, marked as Exhibits "F" to "F-15", respectively, and those shipments which may have previously arrived in the Ports of Manila, those which are expected to arrive or will arrive after the filing of the instant petition or during its pendency in any port within the territorial jurisdiction of this Court; and implementing any alert and/or hold order, and consequently lifting any alert and hold order, relative to petitioner's rice shipments including but not limited to those covered by the Bills of Lading mentioned in the instant petition and those shipments that may have arrived and those that are expected to arrive after the filing of the instant petition or during its pendency in the Ports of Manila that is within the jurisdiction of this Court.
