Amendment to CMO No. 27 - 97 on Insurance

Premiums for Purposes of Assessment of Imports

Item No. 2 of CMO No. 27 - 97 shall read as follows:

"2. If, however, the terms of sale is <u>C&F or FOB</u> and the importer can present a certification from the local insurance/surety firm on the insurance premium paid, then that amount will be used or, ½ % of export value, whichever is higher. In all cases, the higher amount shall be used regardless of the amount appearing in the CRF."
