CUSTOMS MEMORANDUM ORDER

NO. 44-98

Unpaid Warehouse Supervision Fees

The Customs Bonded Warehouse operators listed in the attached report have unpaid warehouse supervision fees. To be able to continue the privilege of having their shipments released under warehousing bonds, their respective accounts should be settled before the end of November, 1998. Otherwise, all shipments consigned to anyone of these operators shall be covered by consumption entries until full payment of the above-captioned fee is received.

This order which shall take effect immediately, shall be applied uniformly to all Customs Bonded Warehouses throughout the country.

All District/Port Collectors are enjoined to submit (Attn.: The Director, Collection Service) their reports of action taken, the Roster of Customs Bonded Warehouses registered within their jurisdiction indicating therein the annual supervision fees collected and the Customs official receipts issued to each of them.

All concerned shall be guided accordingly.

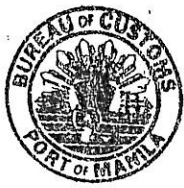
