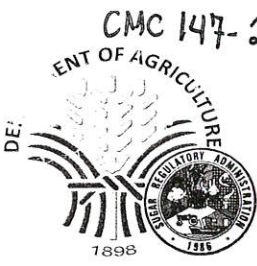

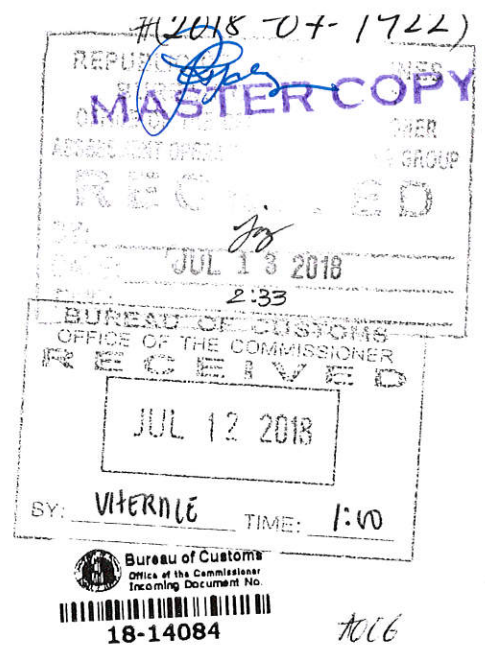

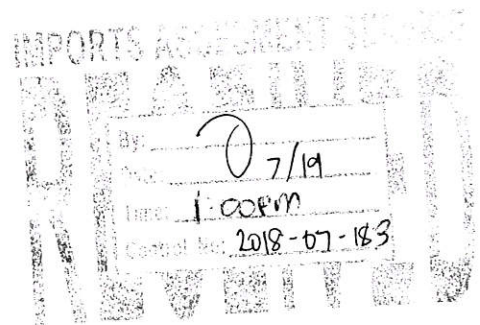
Dear Commissioner Lapeña:
