Attached herewith, for your information is a copy of Revenue Memorandum Order No. 35-2002, dated October 28, 2002, which prescribes the use of BIR Form 1918 and the procedures in the Issuance of Authority to Release Imported Goods (ATRIG) including the designation of Revenue District Officer having jurisdiction over the port of entry as the appropriate office that will receive and process all applications for ATRIG on imported articles from Value Added Tax (VAT) as well as the designation of the Chief, LTD - Davao as the proper approving Official thereof.
