

4. 91-528/16 January 1992 – Expanding Operator of Inter-Island Shipping.

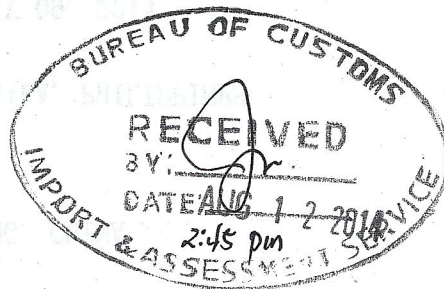
