**Subject: SRA's Clearance on Importation of High Fructose Corn Syrup**

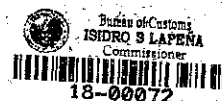

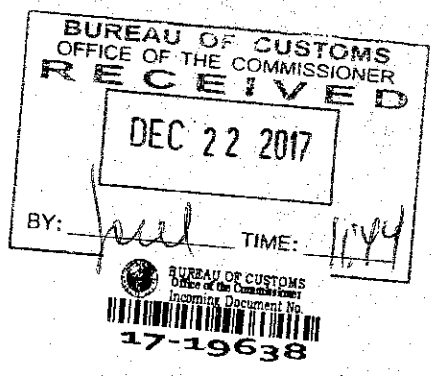


