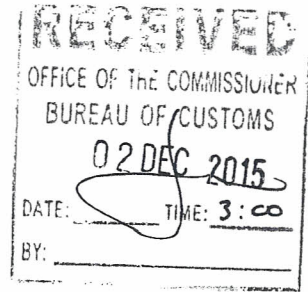

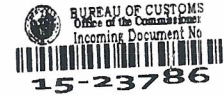

Dear **Commissioner Lina**:

This refers to the on-going arrangement between the Bureau of Import Services and the Bureau of Customs pertaining to the verification of invoices/documents submitted by meat importers. The arrangement was set up to address issues related to customs valuation of imported meat. In the past 18 months of its implementation, we validated the authenticity of over 87% of invoices submitted by meat importers. Attached is the list of exporters/suppliers that have confirmed invoices submitted by importers. Also attached is the list of importers that have consistently submitted invoices which were validated by their suppliers.

Data accumulated during implementation would indicate that the exporters and importers in the attached list pose little risk of undervaluation. For this reason, we don't see the need to continue the arrangement of transaction/invoice specific validation. Thus in regards to the decision to accept or reject declarations made by meat importers, BOC's risk management system can refer to the attached list.
