In line with the Bureau of Customs commitment to implement Rules of Origin (ROO) of various Free Trade Agreements (FTAs) in which the Philippines is a party, all ports are hereby directed to submit at least five (5) original copies and updated customary signatures and initials of your respective Customs Officer authorized to issue and sign Certificate of Origin (CO) including the specimen of the BOC Official Seal. The list of authorized signatories and seal will be transmitted to other member states and shall take effect on May 1, 2018.
3. The approval of the submitted specimen signatures shall be emailed to the respective District and Port Collector.
