Subject Addendum to CMO 28-2006 on the Cargo Information in relation to the implementation of CMO 20-2004 dated 30 June 2004 on the use of the Revised Import Entry and Internal Revenue Declaration (IEIRD-BC Form 236)

The following are the additions to the provisions stated in CMO No. 28-2006, dated 17 August 2006:

II. Scope

"This Order applies to all containerized and bulk shipments consigned to one (1) importer/consignee arriving in a single registry or vessel with similar descriptions. This is regardless of the number of Bills of Lading (B/L) issued to one (1) importer/consignee for a number of shipments loaded in the same vessel."

IV. Operational Provisions

A. Additional Required Information

a. Containerized Shipments

1. The Importer/Broker shall fill in Box# 31 with the following format:

1.1 Container Information

Indicate: # of cntrs. X 20' = total # of 20' cntrs

Enumerate: container nos. of all 20-footer containers below the 20-footer category

Indicate: # of cntrs. X 40' = total # of 40' cntrs
Enumerate: container nos. of all 40-footer containers below
the 40-footer category

Indicate: # of cntrs. X 45' = total # of 45' cntrs
Enumerate: container nos. of all 45-footer containers below
the 45-footer category

GRAND TOTAL OF ALL CONTAINERS: _____

Example:

9 X 20' = 9 of 20' cntrs
AAAA99999999; AAAA99999999; AAAA99999999; etc.
9 X 40' = 9 of 40' cntrs
AAAA99999999; AAAA99999999; AAAA99999999; etc.
9 X 40' = 9 of 40' cntrs
AAAA99999999; AAAA99999999; AAAA99999999; etc.
Where: 9 represent any no. from 0 to 999
A represents any letters

1.2. Specific/Detailed Description of the cargo and license or permit no(s), if any, shall be declared below the Containerized Cargo Information in para IV A.1.a. above.

b. Bulk Shipments

1. The Indicate Cargo/Vessel Hold Number and their corresponding contents in specific terms/detailed description e.g. Cargo Hold No. 1 STC 2,000 bags (50 kgs/bag) Thailand Jasmine Rice 5% Broken
2. Indicate accompanying Import and other permits specifying details such as name of Permit, Permit no., Date of Issue, and Validity.

VI. Effectivity:

This Order shall take effect immediately.
