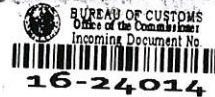
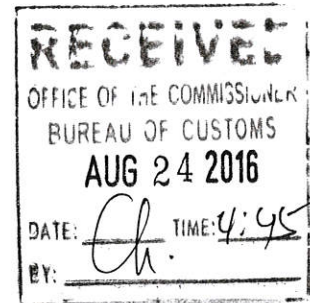


**SUBJECT: COMPLAINT ABOUT CHINESE NATIONAL-XUEFA ZHAO WHICH WAS
