Pursuant to the United Nations declaration dated 7 December 1987 and Presidential Proclamation No. 264, we are once again spearheading the nationwide observance of the International Day Against Illicit Trafficking (IDADAIT) on 26 June 2019. This event will be observed simultaneously by all U.N. Member Countries.

The United Nations Office on Drugs and Crime (UNODC) selects the theme for the International Day and launches campaigns to raise awareness about the global drug problem. For the first time, we will be carrying the theme "Katarungan Para Sa Kalusugan, Kalusugan Para Sa Katarungan".

The program for the IDADAIT 2019 will be held at the Vista Mall Open Parking, Balanga, Bataan on 22 June 2019, 2:00 PM onwards. Fun-run and "Rakrakan Against Drugs", a rock concert featuring famous local bands are the activities that will form part of the IDADAIT celebration.

In this connection, we would like to respectfully request your agency to issue a Memorandum Circular for the said activities intended for dissemination to different offices nationwide.

Furthermore, we would like to respectfully request your agency to undertake activities which are geared towards the attainment of our goals by way of promoting the event and the campaign message through:

- Putting-up streamers/banners in strategic places in your agency (*See attached template*);
- Posting of the event and its theme on your electronic billboard (if any); and
- Participation of your staff during the Event. (*Please note that food, transportation and other incidental expenses shall be borne by the sending organization*).

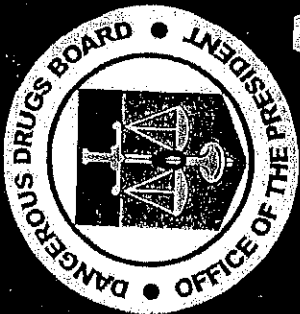
