REFERENCES:

- a. Memorandum from former Internal Administration Group Deputy Commissioner Gladys F. Rosales dated 23 January 2018; and
- b. Telephone conversation with Mr. Christopher Batuhan, Administrative Assistant V of the National Historical Commission of the Philippines (NHCP) on 14 August 2019.

DISCUSSION:

1. On 23 January 2018, former IAG Deputy Commissioner Gladys F. Rosales requested all Deputy Commissioners, Service Directors and District Collectors to submit their Official Emblem to the Chief, Central Records Management Division for approval and registration with Research, Publications and Heraldry Division of the NHCP.
2. Upon verification with the NHCP on 14 August 2019 through a telephone conversation, this Office was informed by Mr. Batuhan that the registration of official emblems with the NHCP is only for the government agency emblems and is not applicable to the emblems used by the sub-offices of the agency.
3. In this regard, the aforementioned Memorandum from former IAG Deputy Commissioner Gladys F. Rosales dated 23 January 2018 is hereby revoked.
