NOTICE AND DECLARATION OF ABANDONMENT

WHEREAS, on 14 June 2021, the Law Division, this Port received the Memorandum dated 11 June 2021 of Mr. Arnoldo L. Famor, Chief, Cargohaus Assessment Composite Unit, forwarding to the Law Division the advance copy of lists of overstaying cargoes for the issuance of decree of abandonment;

WHEREAS, records show that despite notices as attested in the herewith attached Certification dated 07 April 2021, a total of Seven (7) shipments at the Cargohaus CBW No. 125 remained unclaimed, the details of which are as follows:

WHEREAS, the Customs Modernization and Tariff Act (CMTA) states the following:

"Section 1129. Abandonment, Kinds and Effects of .—Imported goods are deemed abandoned under any of the following circumstances:

xxx

b. When the owner, importer, consignee or interested party after due notice fails to file the goods declaration within the prescribed period in Section 407 of this Act; xxx

xxx.

Section 407 of the CMTA states thatGoods declaration must be lodged within fifteen (15) days from the date of discharge of the last package from the vessel or aircraft. The period to file the goods declaration may, upon request, be extended on valid grounds for another fifteen (15) days. Provided, that the request is made before the expiration of the original period within which to file the goods declaration xxx."

WHEREFORE, premises considered, it is hereby ordered and decreed that the above-described shipments be, as it is hereby ordered abandoned in favor of the government pursuant to Section 1129 of RA 10863, otherwise known as the Customs Modernization and Tariff Act (CMTA), the same to be turned over to the Auction and Cargo Disposal Division, this Port, for inventory, custody and safekeeping pending the final disposition thereof in the manner provided for by law.

Let copies of this Notice and Declaration of Abandonment be referred to the Cargohaus Assessment Composite Division, this Port, for service to all parties and offices concerned, and copies thereof be posted on the Bulletin Boards of the Office of the District Collector; Law Division; Office of the Cargohaus Assessment Composite Division, this Port; and electronic posting in the BOC website, thru the Public Information and Assistance Division (PIAD) pursuant to existing Customs laws, rules and regulations.
