RATES FOR THE MOST FAVOURED NATION (MFN) AND THREE

(3) FREE TRADE AGREEMENTS (FTAs)

With reference to abovementioned subject, please find attached herewith a copy of the Tariff Commission (TC) letter providing the summary of identified issues and corrections for the rectification of the BOC database on the 2022 tariff rates for the MFN and three (3) FTAs.

In said letter, the TC made reference to its meeting with representatives from the BOC Imports and Assessment Service, Assessment and Operations Coordinating Group (IAS-AOCG) and the Management Information Systems and Technology Group (MISTG) to discuss the implementation of the 2022 version of ASEAN Harmonized Tariff Nomenclature (AHTN), where the attention of the TC was called on a certain product (i.e., paintings under AHTN 2017 Code 901.10.00) which has a higher MFN rate in 2022 as against its 2021 MFN rate.

After its immediate review, 52 tariff lines in the 2022 MFN, ASEAN-India FTA (AIFTA), Philippines-European Free Trade Association FTA (PH-EFTA FTA) schedules were identified to have issues (i.e., incorrect rates, footnotes, product descriptions; duplicated tariff lines with different rates; error in numbering of extractions) while the line for electrical energy in the three schedules of the PH-EFTA FTA (Switzerland/Liechtenstein, Norway and Iceland) was not included.

Accordingly, the necessary changes were effected in the online Philippine Tariff Finder (PTF) reflecting the correct tariff rates, footnotes and product descriptions as well as adjustments in the number of extractions. Attached hereto is the list of tariff lines with issues and corrections per tariff schedule.

Dear Deputy Commissioner Dy Buco:

May we refer to the 2022 tariff rates for the Most Favoured Nation (MFN) schedule and three Free Trade Agreements (FTAs), i.e., ASEAN-India FTA (AIFTA); ASEAN-Hong Kong, China FTA (AHKFTA) and Philippines-European Free Trade Association FTA (PH-EFTA FTA), which this Commission provided to your good office in our letter dated 05 January 2022.

On 24 February 2022, this Commission met with representatives from the BOC-Import and Assessment Service (IAS) to discuss the implementation of the 2022 version of the ASEAN Harmonized Tariff Nomenclature (AHTN). In the same meeting, the BOC-IAS brought to this Commission's attention that a certain product (i.e., paintings under AHTN 2017 Code 9701.10.00) has a higher MEN rate in 2022, as against its 2021 MEN rate, based on the abovementioned tariff data provided by this Commission last January.

We also subsequently received an email from Mr. Joshua De Rueda, *Tariff Update Team, BOC-AOCG-IAS*, on 02 March 2022 requesting this Commission to "verify the correctness of the 2022 MFN rates that have increased compared to last year's (2021) prevailing MFN rates" specifically for AHTN 2017 Codes. 9620.00.90C, 9620.00.90D, 9701.10.00, 9701.90.00, 9705.00.10, and 9705.00.90.

We would like to thank the team from the BOC-AOCG-IAS for calling our attention on this matter. After the 24 February 2022 meeting, we undertook immediate review of the Commission's database of 2022 MFN and FTA tariff rates against the files provided to your Bureau. Based on the line-by-line review conducted, 52 tariff lines in the 2022 MFN, AIFTA, and PH-EFTA FTA schedules were identified to have issues (i.e., incorrect rates, footnotes, product descriptions; duplicated tariff lines with different rates; error in numbering of extractions) while the line for electrical energy in the three schedules of the PH-EFTA FTA (Switzerland/Liechtenstein, Norway and Iceland) was not included. A summary of the identified issues is provided in the table below:
