

DESCRIPTION OF GOOD

"BVI BALANCED STERILE SALINE SOLUTION"

Based on the material safety data sheets, certificate of inspection, package insert, product literature, complete quantitative formulation of the product, Certificate of Medical Device Registration from the Food and Drug Administration (FDA), product brochure, manufacturing and processing instructions, product label, and product sample submitted, subject article is a sterile, pyrogen-free, limpid, and colorless saline solution for intra-ocular ophthalmic irrigation. It contains a balanced source of electrolytes for the ocular tissues such as sodium chloride, potassium chloride, calcium chloride dihydrate, magnesium chloride hexahydrate, sodium acetate trihydrate, and sodium citrate. It also contains hydrochloric acid or sodium hydroxide to maintain pH compatibility with the ocular tissues. Packed in 25-mL or 500-mL plastic bottles, subject article is used to reduce corneal swelling and maintain the integrity of the corneal endothelium during intraocular perfusion.

REASONS FOR CLASSIFICATION

Heading 30.04 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers medicaments (excluding goods of heading 30.02, 30.05 or 30.06) consisting of mixed or unmixed products for therapeutic or prophylactic uses, put up in measured doses (including those in the form of transdermal administration systems) or in forms or packings for retail sale. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers medicaments consisting of mixed or unmixed products, provided they are, among others, in packings for retail sale for therapeutic or prophylactic use. This refers to products (for example, sodium bicarbonate and tamarind powder) which, because of their packing and, in particular, the presence of appropriate indications (statement of disease or condition for which they are to be used, method of use or application, statement of dose, etc.) are clearly intended for sale directly to users (private persons, hospitals, etc.) without repacking, for the above purposes.

In view thereof, subject article is classified under AHTN 2022 subheading 3004.90.99, with a Most Favoured Nation (MFN) rate of duty of 5% ad valorem.

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

DESCRIPTION OF GOOD

"PROFERRIN® ES (HEME IRON POLYPEPTIDE) TABLET"

Based on the product catalog, product composition, Certificate of Product Registration from the Food and Drug Administration (FDA), and photograph of packaging submitted, subject article is an iron supplement. It is in the form of green tablets containing heme iron polypeptide, croscarmellose sodium, povidone, silicon dioxide, calcium stearate, microcrystalline cellulose, and green coating. Packed in highdensity polyethylene (HDPE) bottles containing 10, 30 or 90 tablets, subject article is to be taken at one tablet daily with food, or as recommended by a physician, to help maintain and support healthy iron levels necessary for oxygen transport, red blood cell production, and sustained energy levels.

REASONS FOR CLASSIFICATION

Note 1(a) to Chapter 30 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 states that this Chapter does not cover foods or beverages (such as dietetic, diabetic or fortified foods, food supplements, tonic beverages and mineral waters), other than nutritional preparations for intravenous administration (Section IV).

Heading 21.06 of the AHTN 2022 covers food preparations not elsewhere specified or included. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that the heading covers, inter alia, preparations, often referred to as food supplements or dietary supplements, consisting of, or based on, one or more vitamins, minerals, amino acids, concentrates, extracts, isolates or the like of substances found within foods, or synthetic versions of such substances, put up as a supplement to the normal diet. It includes such products whether or not also containing sweeteners, colours, flavours, odoriferous substances, carriers, fillers, stabilisers or other technical aids. Such products are often put up in packaging with indications that they maintain general health or well-being, improve athletic performance, prevent possible nutritional deficiencies or correct sub-optimal levels of nutrients.

In view thereof, subject article is classified under AHTN 2022 subheading 2106.90.72, with a Most Favoured Nation (MFN) rate of duty of 7% ad valorem.

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.





DESCRIPTION OF GOOD

"HEPARIN SODIUM (BOVINE) 1000 IU/mL and 5000 IU/mL VIALS"

Based on the product insert, prescribing information, Certificate of Product Registration from the Food and Drug Administration (FDA), and photographs of the product submitted, subject article is an anticoagulant solution for injection, processed exclusively from bovine mucosa. It is indicated for the treatment of thrombo-embolic disorders such as thrombophlebitis, pulmonary embolism, myocardial infarction, arterial embolism, and other occlusive vascular disease. It is also used to prevent thrombo-embolic complication from cardiac and vascular surgery, dialysis, frostbite, and other perfusion procedures and as an anticoagulant in blood transfusions and for laboratory purposes. Subject article is packed in boxes containing 5-mL glass vials with 1,000 IU/mL and 5,000 IU/mL, and 30-mL glass vials with 1,000 IU/mL.



5 REASONS FOR CLASSIFICATION

Heading 30.04 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers medicaments (excluding goods of heading 30.02, 30.05 or 30.06) consisting of mixed or unmixed products for therapeutic or prophylactic uses, put up in measured doses (including those in the form of transdermal administration systems) or in forms or packings for retail sale. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers medicaments consisting of mixed or unmixed products, provided they are, among others, put up in measured doses or in forms such as tablets, ampoules (for example, redistilled water, in ampoules of 1.25 to 10 cm³, for use either for the direct treatment of certain diseases, e.g., alcoholism, diabetic coma or as a solvent for the preparation of injectible medicinal solutions), capsules, cachets, drops or pastilles, medicaments in the form of transdermal administration systems, or small quantities of powder, ready for taking as single doses for therapeutic or prophylactic use. The heading applies to such single doses whether in bulk, in packings for retail sale, etc.

The Supplementary Explanatory Notes (SEN) to AHTN 2022 subheading 3004.90.89 state that these are medicaments which are solely formulated for patients with cancer, heart ailments, Human Immune-deficiency Virus (HIV)/Acquired Immune Deficiency Syndrome (AIDS) or HIV/AIDS, renal failure or other lingering illnesses and used by the patient as maintenance to suppress the patients' condition at its present level or prevent possible complications. These include antineoplastic medicines, dialysis solutions and preparations, chemotherapy solutions, and cardiovascular drugs.
