- Pursuant to Civil Service Commission Memorandum Circular No. 12, s. 2005 re: 1.0 Use of Non-Sexist Language in All Official Documents, Communications, and Issuances, this Bureau is enjoining all officials and employees to strictly observe the use of non-sexist or gender-fair language in all officials, documents, communications, and issuances to avoid implicit and explicit discriminatory language against women or men.
- 2.0 Relative thereto, attached are guidelines on the use of non-sexist or gender-fair language in accordance with the above-cited CSC Memorandum Circular and based on the Gender-Fair Language: A Primer, which was published by the University of the Philippines Center for Women's Studies (Annex "A").

#### GUIDELINES ON THE USE OF NON-EXIST FOR GENDER-FAIR LANGUAGE Source: CSC MC No. 12 (s. 2005)

- Eliminate language, words, written and verbal that renders invisible persons of another gender and/or diverse sexuality.
- Eliminate the generic use of HE, HIS, HIM unless the antecedent is obviously male by:

Traditional: The interior designer uses his sketch to guide him.

Suggested: The interior designer uses the sketch as a guide.

3. Deleting he, his and him altogether, rewording if necessary:

Traditional: The interior designer uses his sketch to guide him

Suggested: The interior designer uses a sketch as a guide.

4. Substituting articles (a, an, the) for HIS; using WHO instead of HE:

Traditional: The singer should know his lyrics well.

Suggested: The singer should know the lyrics well.

5. Replacing the specific gender into ONE, WE or YOU:

Traditional: As one grows older, he becomes more matured


Suggested: As one grows older, one becomes more matured.

6. Eliminate the generic use of Man. Instead, Use People, Person(s), Human(s), Human Being(s), Humankind, Humanity, the Human Race:

Traditional: In an army no <u>man</u> is permitted to leave without permission.

- 7. Eliminate sexism in symbolic representations of gender in words, sentences. and texts by:
  - 7.1 Taking the context of the word, analyzing its meaning, and eliminating sexism in the concept:

Traditional: The common man

Suggested: The average person

Traditional: The father of history

Suggested: The founder of history

Traditional: Brotherhood

Suggested: Fellowship

7.2 Finding precise words to delineate the thing itself from supposedly sexlinked characteristics:

Traditional: Mother Nature focuses on the life-giving and she nurturing aspects of nature.

Suggested: Nature focuses on the life-giving and it nurturing aspects of nature.

- 8. Eliminate sexual stereotyping of roles by:
  - 8.1 Using the same term for both genders when it comes to profession or employment:

Traditional: Policewoman, Policeman

Suggested: Police Officer

Traditional: A man-sized job.

Suggested: A demanding task.

8.4 Avoiding language that catches attention to the sex role of men and women:

Traditional: Working mothers

Suggested: Wage-earning mothers

9. Eliminate sexism when addressing persons formally by:

9.1 Using Ms. Instead of Mrs.

Traditional: Mrs. Dela Cruz

Suggested: Ms. Dela Cruz

9.2 Using a married woman's first name instead of her husband's:

Traditional: Mrs. Maria Dela Cruz

Suggested: Ms. Maria Reyes-Dela Cruz
