CUSTOMS MEMORANDUM ORDER

TO: All Collector of Customs All Chiefs, Cash Division

All Chiefs, Formal Entry Division All Ports

SUBJECT: Procedure in the collection on Post-Dated Checks under CMO 51-92 and CMO 12-93

In order to expedite collection on Post-Dated Checks (PDCs) for cases already resolved, the following procedures are hereby prescribed:

- Where the amount of the PDC is equivalent to the amount payable stated in the Committee decision/resolution, the Chief, Cash Division shall:
 - 1.1. deposit the PDC with PNB or Bureau of Treasury, as the case maybe
 - 1.2. in case the check is dishonored for lack of funds or insufficient funds, send demand letter by accomplishing the attached format (Annex "A")
 - 1.3. after expiration of the 5-day period and no payment is made, indorse the case to the Legal Service through the BOC-SGS IVCC for filing of the criminal case under the Revised Penal Code and the Bouncing Check Law
- Where the amount of the PDC is more than the amount payable stated in the committee decision/resolution, the Chief, Cash Division shall:
 - 2.1. send a letter-advise with return card to the importer by accomplishing attached format (Annex "B")
 - 2.2. after expiration of the 5-day period, deposit the PDC with the Bureau of Treasury or the PNB;

- 2.3. in case the check is dishonored for lack of funds or insufficient funds, send the importer a demand letter with return card by accomplishing (Annex "C")
- 2.4. after expiration of the 5-day period and no payment is made, indorse the case to the Legal Service through the BOC-SGS IVCC for filing of the criminal case under the Revised Penal Code and the Bouncing Check Law.
- 3. the Chief, Cash Division shall submit weekly report of all pending FCDs to be updated weekly by accomplishing the attached format (Annex "D"), having the following columns:
 - 3.1. CRF Number and Post-dated check Number
 - 3.2. Date the case was received by the Cash Division from the Formal Entry Division
 - 3.3. Date the Letter-advise (Annex "B") was received by the importer
 - 3.4. Date the Demand-letter (Annex "C") was received by the importer
 - 3.5. Date the case was transmitted to the Legal Department through the BOC-SGS IVCC

All orders, memoranda, rules or regulations, inconsistent herewith are deemed repealed.

This order shall take effect immediately.
