Qualifying Examinations for Promotions

## I. OBJECTIVES:

Pursuant to CMO Nos. 120-88 and 14-91, the Bureau of Customs through its Promotions Board will be conducting a Qualifying Examination for the purpose of ranking personnel applying for promotions to selected positions.

## 11. AREAS OF EXAMINATION:

A written examination will be given to all interested personnel who would wish to be considered for promotions to the following positions:

Customs Appraiser

2. Customs Examiner/Assessor

Customs Inspector/Wharfinger I & II
 Entrance & Clearance Officer 1 & II

## III. QUALIFICATIONS of EXAMINEES:

All personnel who meet the qualifications as stated for each position below may take the respective examinations:

## 1. Examination for Customs Appraiser

This is open to all personnel holding the positions of Customs Examiner, Customs Assessor, Sr. Trade Control Examiner and such other positions within the salary grade from 12-15 and who meets the following required qualifications:

- a. Bachelor's degree in Customs Administration or Bachelor's degree relevant to the job;
- b. 2 years experience in Customs Assessment work,
   1 year for graduates of BSCA;
- c. Career Service (Professional) or other relevant eligibility for second level position.

## 2. Examination for Customs Examiner/Customs Assessor

This is open for all personnel holding a position with equivalent SG-15 or below and who meet the following required qualifications:

- Bachelor's degree in Customs Administration or Bachelor's degree relevant to the job;
- b. 2 years experience in Customs Assessment work,
   1 year for graduates of BSCA;
- c. Career Service (Professional) or other relevant eligibility for second level position.

## 3. Examination for Customs Inspector/Wharfinger 1

This is open for all personnel holding a position with equivalent SG-11 or below and who meet the following qualifications:

- a. Completion of 2 years coilege work;
- b. 1 year experience in customs inspection or other related work;
- c. Career Service (Sub-Professional) or other relevant eligibility for first level position.

## 3. Examination for Wharfinger II & Entrance & Clearance Officer I & II

This is open for all personnel holding a position with equivalent SG-9 or below and who meet the following qualifications:

- a. Bachelor's degree relevant to the job;
- b. 1 year experience in port operations and other related work;
- c. Career Service (Professional) or other relevant eligibility for second level position.
