CUSTOMS MEMORANDUM ORDER

NO. 16-2004

SUBJECT: DEFINITIVE GENERAL SAFEGUARD DUTY ON
IMPORTATIONS OF GLASS PRODUCTS COVERED BY THREE
(3) DTI ORDERS DATED 14 APRIL 2004

Pursuant to the herein 2nd Indorsement, dated 31 May 2004, signed by Secretary Juanita D. Amalong, Department of Finance, relative to the letter request dated 05 May 2004 of Secretary Cesar V. Purisima, Department of Trade and Industry, requesting the Bureau to "collect the appropriate amount of the definitive general safeguard duty on the importations of glass products covered by" DTI Orders dated 14 April 2004 in Safeguard Investigation Nos. 01-2003, 02-2003 and 03-2003. This Office hereby directs the immediate implementation of the said DTI Orders with respect to the following:

1. Figured Glass (H.S. Code 7003.1290 now AHTN Nos. 7003.1220 and 7003.1290 and H.S. Code 7003.1990 now AHTN Nos. 7003.1920 and 7003.1990);
2. Float Glass (H.S. Code 7005.1990 now AHTN Nos. 7005.2920 and 7005.2990 and H.S. Code 7005.2190 now AHTN Nos. 7005.2120 and 7005.2110); and
3. Glass Mirrors (AHTN Subheading Nos. 7009.9100 and 7009.9200).

The said DTI Order imposing definitive general safeguard measures as follows:

CMO re Definitive Safeguard Duty on Importation of Glass Products (Page 2)

The first year of implementation of the definitive general safeguard duty shall include the period in which the provisional safeguard took effect i.e. 13 October 2003, the date of issuance of CMO No. 24-2003.

The measures shall be effective from the date of signing of this Customs Memorandum Order or fifteen (15) days after the publication of the DTI Orders in two (2) newspapers of general circulation, whichever comes earlier.

Let copies of DTI Orders on the above cases, including the list of developing countries excluded from the imposition of definitive safeguard measure in each case be appended to this CMO.
