## WARRANT OF SEIZURE AND DETENTION

To: SP/Capt. Arnel A. Baylosis District Commander

ESS-CPD, Port of Clark

Greetings!

WHEREAS, on 21 October 2021, a shipment from British Columbia, Canada said to contain "PAINTING SUPPLIES, COLOURING MATERIALS, AND PAINT BRUSHES" consigned to a certain MJ VALENCIA arrived at the Federal Express (FedEx) Clark Hub under House Airway Bill No. 284986994691 was marked "X" by the BOC X-ray Inspection Project during the routine inspection;

WHEREAS, on even date, subject shipment was subjected to K9 sweeping which yielded positive indications containing illegal drugs. Thereafter, Acting Customs Examiner Japhet Mercado conducted physical examination on the subject shipment which led to the following findings:

WHEREAS, on 26 October 2021, a sample of the subject shipment was tested by the Customs Anti-Illegal Drug Task Force (CAIDTF) which gave a positive result for the presence of Marijuana. Subsequently, representative samples were taken from the subject shipment and turned over to PDEA Intelligence Officer I Aldron L. Rabin for the conduct of laboratory testing and chemical analysis;

WHEREAS, PDEA Chemistry Report No. PDEA-RO3-21-0143 dated 26 October 2021 confirmed that qualitative examination conducted on the subject shipment gave **POSITIVE** result for the presence of **TETRAHYDROCANNABINOL/MARIJUANA**;

WHEREAS, on 10 November 2021, the Office of the District Collector received a Memorandum dated 08 November 2021 from Mr. Mercado and Mr. Karl Cortes, Acting Customs Examiner and FedEx Special Duty Collector, respectively, thru Atty. Danilo G. Ballena Jr., Acting Deputy Collector for Assessment, recommending the issuance of a Warrant of Seizure and Detention (WSD) against the subject shipment for violation of Sections 118 (g), 119 (d), and 1113 par. f, i, and I of Republic Act (R.A.) No. 10863 otherwise known as the Customs Modernization and Tariff Act (CMTA) in relation to R.A. No. 9165 otherwise known as the Comprehensive Dangerous Drugs Act of 2002;

WHEREAS, upon evaluation thereof, this office finds probable cause for the issuance of WSD against the subject shipment for violation of Sections 118 (g), 119 (d), and 1113 par. f, i, and I (3 & 4) of R.A. No. 10863 otherwise known as the Customs Modernization and Tariff Act (CMTA) in relation to R.A. No. 9165 otherwise known as the Comprehensive Dangerous Drugs Act of 2002.

WHEREFORE, by virtue of the power vested in me by law, and in compliance with pertinent Customs law, rules and regulations, you are hereby ordered to forthwith seize the afore-mentioned articles and turn-over the same to PDEA in accordance with R.A. No. 9165. In this connection, please be guided by Customs Memorandum Order No. 8-84, particularly on the matter of making a return of service and submission of inventory of list of the subject articles.
