Dr. Wivina B. Pumatong, CESE, District Collector, had a meeting with Iloilo City Engineer Representative and a Contractor, regarding the re-wiring of Iloilo Customs House Building on May 2, 2019 at 2:00 P.M. at Collectors Office, Customs House Building, Muelle Loney Street, Iloilo City.

For this week, the entire district has a total of Twenty (20) entries filed; export and formal entries.

At the main office, Six (6) formal entries filed and in progress. Seven (7) Export entries were filed, five (5) enties were completed and two (2) entries in progress; and Three (3) Informal entries were completed.
