April 12 - 18, 2019

Santua, Jr., Collector of Customs I, Kalibo International Airport, Division Chiefs and men and women of Collection District VI had a General Meeting at Assessment Division, Iloilo Customs House Building, Muelle Loney Street, Iloilo City on Monday, April 15, 2019 at 2:00 P.M.

For this week, the entire district has a total of Thirteen (13) entries filed; export and formal entries.
