Dr. Wivina B. Pumatong, CESE, District Collector, attended the 2nd Coordination Meeting on April 11, 2019 at 1:00 P.M. at Penthouse 1, Iloilo City Hall, for the upcoming Regional Inter-Agency Drugs Coordinating Group (RIDG) by Philippine Drugs Enforcement Agency (PDEA) VI, Iloilo City.

For this week, the entire district has a total of Eleven (11) entries filed; export and formal entries.

At the main office, Four (4) formal entries filed and in progress. One (1) Export entries was filed and completed and one (1) Informal entry was completed.

For the Subport of Pulupandan, seven (7) entries were filed, two (2) formal entries and five (5) export entries were in progress.
