Coll. Noli P Santua Jr., Officer-in-Charge, Port of Iloilo, participated in the Video Conference together with Commissioner Rey Leonardo B. Guerrero, Deputy Commissioner, District Collectors and Service Collectors on Monday, March 2, 2020 at 7:30 A.M. to 10:00 A.M.

Coll. Noli P Santua Jr., Officer-in-Charge, Port of Iloilo, conducted a meeting with the Divisions Chief on issues and concerns of each Division's, which includes the following: The used of biometrics, the Bureau's collection target for this year, the proposed adjusted target for this year, the proposed Customs Office in Loboc, Lapaz, Iloilo City, Border protection, safety and other measures to combat corona virus especially those personnel assigned in the operations division and the submission of OPCR/IPCR.

For this week, the entire district has a total of Seventeen (17) entries filed; export and formal entries.

At the main office, Ten(10) formal entries were filed, One(1) entry was completed and Nine (9) entries in progress; One (1) Informal entry was filed and completed; and One(1) Export entry was filed and completed.

For the Sub-port of Pulpandan, Five (5) Formal entries were filed, Three (3) entries were completed and (2) entries were in progress; No Informal and Export entries was filed for this week.
