

*February 1, 2019 - February 7, 2019*

Dr. Wivina B. Pumatong, CESE, District Collector, had a meeting at Conference Room, Civil Aviation Authority of the Philippines, Iloilo International Airport, Cabatuan, Iloilo on February 7, 2019 at 10:00 A.M. regarding installation of X-Ray check-in baggage and hand carried baggage at Iloilo International Airport.

Dr. Wivina B. Pumatong, CESE, District Collector, had a MOA signing at Philippine Ports Authority, Loboc, Lapuz, Iloilo City together with other partner agencies on February 7, 2019 at 10:00 A.M. on the creation of the Seaport Inter-Agency drug Interdiction Task Group – Western Visayas
