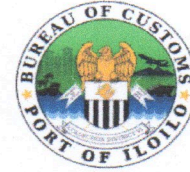

For this week, the entire district has a total of Fourteen (14) entries filed; export and formal entries.


At the main office, Four (4) formal entries were filed and in progress, Four (4) Export entries were filed and one (1) entry was completed.
