## March 15- 21, 2019

Dr. Wivina B. Pumatong, CESE, District Collector, had a meeting with the Assessment personnel regarding Collection Target on March 19, 2019 at 2:00 P.M. at the Collectors Office, Customs House Building, Muelle, Loney St., Iloilo City.

For this week, the entire district has a total of Eight (11) entries filed; export and formal entries.

At the main office, Eight (8) formal entries were filed and in progress, Four (4) Export entries were filed and completed.

For the Subport of Pulupandan, Three (3) formal entries were filed, Two (2) entries were completed and one (1) entry in progress.
