NARRATIVE REPORT

March 7- 14, 2019

Dr. Wivina B. Pumatong, CESE, District Collector, had a meeting with Mr. Edgardo A. Ferrer, Chief, Licenses, Patents, and Deeds, CENRO, Guimbal, Iloilo, on March 8, 2019 at 10:00 A.M. at the Collector's Office, Customs House Building, Muelle Loney Street, Iloilo City, regarding the processing of Lot Title of BOC, Port of Iloilo requesting for the Survey Authority as a prerequisite by the Land Management Bureau to approve the Lot Plan.

Dr. Wivina B. Pumatong, CESE, District Collector, was interviewed by Financial Management Students of University of San Agustin, Iloilo City as required by their subject Public Finance to conduct an interview among Government Offices with regards to Public Finance on March 11, 2019 at 3;00 P.M. at the Collector's Office, Customs House Building, Muelle Loney Street, Iloilo City.

For this week, the entire district has a total of Twenty Two (22) entries filed; export and formal entries.

At the main office, Ten (10) formal entries were filed and in progress. Three (3) Informal entries filed and completed; and Four (4) Export entries were filed and completed.

For the Subport of Pulupandan, Five (5) formal entries were filed, Two (2) entries were completed and Three (3) entries in progress.

There are no reports for balikbayan boxes, auctions, alert orders and apprehensions.
