## NARRATIVE REPORT

May 10 – 16, 2019

Alan N. Aladano, DM, DSC, Regional Director, BFP 6 on May 15, 2019 at 11:00 A.M. at the Collectors Office, Customs House Building, Muelle Loney Street, Iloilo City.

Dr. Wivina B. Pumatong, CESE, District Collector, had a meeting with Philippine Coast Guard regarding entries of Foreign Vessels on May 15, 2019 at 1:30 P.M. at Iloilo Coast Guard Station, Fort San Pedro, Iloilo City.

Dr. Wivina B. Pumatong, CESE, District Collector, supervised the conduct of Competency – Based examination and interview of applicants for Administrative Services Assistant under Contract of Service for Kalibo International Airport and Iloilo International Airport on May 16, 2019 at Rigor Hall, Customs House Building, Muelle Loney Street, Iloilo City.

For this week, the entire district has a total of Ten (10) entries filed; export and formal entries.

At the main office, Three (3)) formal entries were filed; Two (2) entries were in progress and one (1) entry was completed, There are no informal entries filed; and Five (5) Export entries were filed and completed.
